The Licence applies to the entire Software. This Licence defines the terms and conditions under which the Software may be used and are guaranteed by our company unless otherwise required by law.

1- PROPERTY RIGHTS

It is expressly stated that the Software and all of their components remain the full and entire property of Fillon Technologies, the Customer acquiring no rights and in particular no right of ownership over these elements by virtue of the sale of the Daisy Wheel product, with the exception of the User Licence granted by Fillon Technologies to the Customer under the conditions stipulated below.

More generally, Fillon Technologies does not assign or grant any intellectual property right, even partial, on the Daisy Wheel product or all of its components, in particular the Software and more generally for studies, information, analyses, files, documents, know-how, patents, inventions or otherwise, except for the User License granted by Fillon Technologies to the Customer under the conditions stipulated below.

2 – USER LICENCE

2.1 Authorised use

Fillon Technologies hereby grants the Customer a non-exclusive and non-transferable Licence to use the Software which includes the rights exhaustively listed below:

- Right to install the Software on 1 computer necessary for the installation and use of the Daisy Wheel product,
- Right to use the Software by 1 user solely within the framework of the exclusive use of the Daisy Wheel product and the strictly internal and personal needs of the Customer,
- Right to make a backup copy of the Software, provided that such copy is necessary to preserve the use of the Software and that such copy is used solely for the purpose of restoring the Software. The copyrights of Fillon Technologies and all third parties must be included in the backup copies,

Excluding any other use.

The Customer will use the Software only in its object code form.

2.2 Non-authorised use
